Greetings Colleagues! The Delaware Valley Chapter continues the academic year with an event-filled spring. This year's spring program, "Open Access Publishing: Trend or Transformation?" features the speakers and content scheduled as our fall program, which was canceled due to inclement weather. The spring program is also the designated date of the Annual Membership Meeting, at which a "State of the Chapter" will be delivered, detailing the usual quantitative characteristics of the Chapter, plus qualitative descriptions of the Board's work on Chapter maintenance and planning for its future.

At the national level, ACRL has just announced the first Scholarly Communication Institute, co-sponsored with the Association for Research Libraries (ARL). As stated by ACRL: "This jointly sponsored institute offers tools and techniques to build a scholarly communication program or move an existing program

to the next level. Participants will assess their campus environment before the institute, engage in two-and-one half intensive days of active learning, and develop customized outreach plans to implement at their home institutions." ## 2006 Spring Program

### *Open Access Publishing: Trend or Transformation?*

*Doreen Kopycinski, Lehigh University*

A snowstorm kept us from holding our regularly scheduled fall program but, because of the interest in the topic, we have planned *Open Access Publishing: Trend or Transformation?* as the ACRL/DVC spring program. The program will be held on March 24 at the American College in Bryn Mawr.

The keynote address will be delivered by **Dr. Ray English**, Director of Libraries at Oberlin College. He has been active nationally on scholarly communications issues for a number of years, including as a primary leader of the ACRL scholarly communications program since its inception. Currently, he chairs the ACRL Scholarly Communications Committee. For many years, Dr. English has also been a member of the steering committee of SPARC (Scholarly Publishing and Academic Resources Coalition) and was recently elected chair of the committee. He edits the scholarly communications column for *College & Research Library News* and he writes and speaks frequently

on scholarly communications issues in a variety of contexts. He received his A.B. from Davidson College and Ph.D. and M.A. (in German literature) as well as his MLIS from the University of North Carolina at Chapel Hill.

Dr. English notes "for my talk at the ACRL Delaware Valley Chapter workshop, I plan to give a broad and relatively brief overview of issues in the system of scholarly communication and then focus on open access as the most powerful change strategy developed so far. I expect I'll work in a few jokes and one-liners along the way."

In the afternoon, Dr. English will be joined by a panel of guests to continue the discussion of open access and how it is affecting information provision, library service, and those the library serves. The panel will consist of:

## *"I Feel I Have Learned a Great Deal from Her..."*

### *Reflections on the ACRL/DVC Mentoring Program*

When the opportunity to serve as a mentor for library school students was offered by the ACRL/DVC, I jumped at the chance to volunteer. After all, I have worked in libraries (public, school, corporate and academic) for over thirty years. I love my work; I enjoy interacting with students and faculty and especially enjoy the academic environment. I find it particularly rewarding when students and faculty express their gratitude after I have taught and worked with them to find just the information they need to complete their assignments, presentations, etc. If I am able to pass on this enthusiasm to someone just starting out in the field, I would be pleased.

My first mentee was in his last year at Drexel and already working in a non-public area of an academic library. When I described the duties an academic reference librarian performs he said "that sounds like my ideal job." We corresponded by e-mail and on his breaks during Wednesday classes at Drexel, we chatted via Widener's Virtual Reference. We met when he applied for an entry level reference librarian's position at Widener. Although he was not hired here, we continued to stay in touch and when an entry level position opened up at Neumann College shortly thereafter, I urged him to apply. He was hired and all involved were very pleased. He had found his "ideal job" and the students, his coworkers, and the college community felt he was a "good fit." However, circumstances in his personal life led to his having to leave the area to settle in Indiana. He began working in the university library there but has decided to return to school where he is enrolled in his second semester in the Turkish language and is taking a course on "libraries as a support for democracy in Turkey." In 2007 he will serve as a "consultant for a public library project in eastern Turkey."

My current mentee is a young woman at the very beginning of her library school career. She has an undergraduate degree in computer science but is not interested in pursuing that field. When I asked her why she had signed up for the mentoring program, she answered that she "needed direction." She is uncertain as to which area of librarianship she wants to enter and has not yet had an opportunity to work in a library setting. So far we have discussed courses she should take and memberships in appropriate professional organizations. She is actively seeking to enter the internship program through Drexel in order to get exposure to various library settings. Initially we corresponded by e-mail and last weekend we spoke on the phone. In the near future I will extend an invitation for her to come and spend time with me while I am on duty and have her observe "a day in the life of a reference librarian." I look forward to continuing this relationship with her and I hope to continue to serve in this program with ACRL/DVC.

*Teresa's current mentee included the following note:*

Although my mentor, Teresa Cartularo, and I have had only a few email conversations, I feel I have learned a great deal from her. I have no professional experience working in a library. However, through Teresa's extensive professional background, I am excited to enter into the profession. She has helped me choose a few professional organizations that will best suit my needs as a student and upcoming library professional. She has also advised me on the types of classes to take in the next semesters. Corresponding with Teresa has been a great pleasure and I look forward to conversing with her as she guides me through my academic career and hopefully through my professional career as well.

Professor Weintraub is an active research mathematician, was the lead organizer of a one-day conference “Scientific Publishing: What Does the Future Hold?” held at Lehigh in November 2005, and he serves on the Committee on Publications of the American Mathematical Society.

Preceding the keynote address will be a poster session, during which local libraries will share their efforts and ideas on how they are approaching the open access movement on their campuses. After lunch, there will be additional time to review the poster presentations and then to join the ACRL/DVC Board for the annual meeting, during which the student stipend recipient will be announced. The poster presenters will join the afternoon panel to continue the discussion on open access and answer any questions from the audience.

The ACRL/DVC Board wants to encourage attendees to invite faculty outside the library to attend. The topic of scholarly communication is something about which librarians and faculty should be engaged and this program can serve to begin or continue that conversation

The area of scholarly communication presents many challenges for librarians today. Join us for this session as we consider how the issues are being addressed.

This workshop has been partially funded with Federal Library Services and Technology Act (LSTA) funds administered by the Office of Commonwealth Libraries.

## Catching up with an ACRL/DVC Stipend Winner

Mary Metzger, University of North Carolina at Charlotte

Mary Metzger was a recipient of an ACRL/DVC stipend in 2003. Following, she shares with us what she how her library career has progressed since then.

I graduated from Rutgers University (SCILS) in August 2003 and began work at the University of North Carolina at Charlotte the following January. At Atkins Library, I am the staff development librarian and serve on the instruction team.

UNC Charlotte is a rapidly-growing campus, with slightly over 20,000 students. It is one of sixteen schools in the UNC system. Many of the undergraduates at UNCC are the first members of their families to attend college. A substantial number are older students who are returning to school, having interrupted their educations to rear children or take a job. Residents of the Charlotte area, and North Carolina generally, are adapting to new economic realities. North Carolina traditionally relied on the manufacturing and production of textiles, furniture, and tobacco products. Now, much of that work has gone overseas. People are in school to develop new marketable skills and advance their educations. Additionally, people from other regions in the U.S. have moved to Charlotte because it is a regional center for banking and health care. Enrollment at UNCC is projected to grow to over 28,000 by 2012 and it will be challenging to expand library services to keep pace with students' needs.

Since arriving at Atkins Library, I have planned and coordinated training programs and worked with students in classes. I participated in the ACRL Immersion program last summer and have also become involved in local oral history. A colleague and I supervised the gathering of interviews with African-American residents of Charlotte whose educations were shaped by segregation and, later, by the *Brown v Board of Education* decision. These interviews will become part of the publicly-accessible oral history collections that are part of Atkins Library special collections.

I was grateful to have received an ACRL-DVC stipend in 2003. The stipend helped me complete my degree on time, amid working part-time and being a parent to two teenaged boys. Members of ACRL-DVC should be proud of the chapter because of such programs that include outreach to graduate MLS/MLIS students. In time, I hope an ACRL chapter here can be as successful.



## Chapter Funding from ACRL National

Good news from ALA Midwinter. The ACRL Board of Directors, at its January 24, 2006 meeting in San Antonio, approved a request from ACRL Chapters Council to allow ACRL Chapters to spend budgeted resources on any items or activities that support the achievement of the ACRL National strategic goals with the following two exceptions:

- 1) The allotted funds may not be used for payment of honoraria or travel to support librarians' presentations at ALA, ACRL, or ACRL chapter conferences and
- 2) The allotted funds may not be used to purchase goods or services prohibited by ALA and ACRL policy.

The ACRL Board thanked Chapters Council for bringing these proposals forward for consideration. The changes will give the chapters more flexibility in carrying out their programmatic activities.

## National Library Legislative Day 2006
