# 2007 Fall Program Review: Finders, Seekers, Info Keepers

The ACRL Delaware Valley Chapter held its Fall 2007 event, 'Finders, Seekers, Info Keepers: Connecting with Today's Students,' November 2 at West Chester University's Graduate Business Center. About 70 people turned out to hear the morning speakers, Lynn Silipigni Connaway, Consulting Research Scientist at OCLC, and Marie Radford, Associate Professor at Rutgers University's School of Communication, Information and Library Studies. Connaway spoke on Making the Library More Accessible. Her research attempts to understand how and why people search for and access information in various situations. She described two recent projects that used individual and focus group interviews to identify perceptions and attitudes toward information seeking of targeted populations, including college and university students. She offered several quotes and observed behaviors gathered in these studies that are startling on the surface, but which many of us know to be the case:

- Students often turn to their parents for information help, especially fathers, as they 'know everything, or can find it out.'
- Both undergraduate and graduate students tend to turn to Google and then human advisors for help, and some showed embarrassment at this.
- Students' needs are often highly interdisciplinary, and libraries' ordered subjects often don't match up.
- Libraries are used as a backup to data accessed through personal electronic devices. When they do use the library, students would like to see more roaming personnel, with a coffeehouse atmosphere. They would like us to lessen the

intimidation factor, and provide better signage.

The second study had to do with chat and virtual reference (VR), and turned up equally useful results.

- Students have been taught not to speak with people online they don't know, and that's what VR asks them to do. However, the trust factor is big if it is recommended by an adult, they will use a library's VR.
- Graduate students would rather speak with someone they know, face to face.
- The people who do use VR really like that there is a collaborator available.
- VR provides access for people who won't come into the library. And at this remove, they will ask more challenging, in-depth questions than they would ask in person.
- They don't want to bother the librarian, even online. Privacy is an issue in that they don't want us to know what they don't know. We need to let them know we want them to ask, more.

Connaway asked the audience how librarians can respond to these realities. Her research shows that a common response is to find them troubling, but this does not necessarily lead us to actually listen and respond to the users' requests. Recognizing that some people just don't use libraries, we could help them by making the experience more like the experience available elsewhere online. Her studies show that we need to be comprehensive and in the research flow, our services should telescope from the personal to the global, there should be a low transaction cost, and our services should be reflective of the people using our systems.

Radford's talk was called Creating Chat Connections: E-valuating Virtual Reference Transcripts, based on a study which examined 850 random QuestionPoint transcripts selected over two years from over 500,000 users. She offered several good insights:

- An average VR session took just over 12 minutes. There doesn't have to be a rush online.
- People don't use VR because they're in a hurry they just may be more comfortable there, or at a distance.
- Users prefer face to face help, then chat, then phone and email. They remember when a librarian treats them well, and the opposite.
- Barriers to good chats include limiting the time spent, sending them to Google, reprimanding, abrupt chat endings, and refusals to provide information.
- Basic interpersonal skills go a long way toward successful VR interactions – be yourself, greet them, recognize that they may be intimidated, show awareness, empathy, humor, provide an answer, and say goodbye.

The afternoon panel added Alexia Hudson, Reference and Instruction Librarian at Penn State Great Valley, and Thomas Mogan, Director of Student Development at Villanova University into the mix.

Hudson spoke briefly about her work in connecting with students in Second Life, and Mogan talked about how Villanova used a One Book effort to bring students, faculty and staff together.

Questions from the audience focused heavily on balancing how we connect with students online, and how we continue to teach them what they need to know to do their work and to learn. How can we decide between rigorous academic practice, and just providing the answer? Is it possible to offer both scholarly instruction, and seamless service? All the panelists agreed that while it's a challenge, it is possible and necessary for libraries to offer our traditional educational services, and move forward in offering the Web 2.0 and 3.0 interactions that our students want.

# News from ACRL Chapters Council at ALA Midwinter

Representatives from ACRL chapters meet twice each year, at ALA Midwinter and Annual, to discuss matters of concern to chapter members. The Chapters Council Board, ACRL officers, staff members, and ALA representatives update attendees on a variety of issues, which are then reported back to chapter members.

This year's Midwinter meeting took place from 8:00 am to 11:00 on January 13, in Loews Hotel. Julie Todaro, ACRL President, talked about several ACRL developments. ACRL's wiki (http://wikis.ala.org/acrl/index.php/ACRL\_New\_Member\_Wiki) is a resource for new members. There are plans to expand it for the purposes of recruitment and retention; an expanded version of the wiki will be introduced at ALA Annual. ACRL Insider, ACRL's blog located at http://www.acrl.ala.org/acrlinsider/, records the business of the association.

Descriptions of librarian positions in the CUPA-HR (College and University Professional Association for Human Resources) compensation surveys have now been updated. See http://www.cupahr.org/surveys/salarysurvey2007-08.asp for the revised library-related industry standard titles and their descriptions. They can be found in two spreadsheets, Administrative Compensation Survey/Position Descriptions and Mid-Level Survey/Position Descriptions, available for downloading at the CUPA-HR survey site.

The success of ALA/ACRL-backed federal legislation mandating the availability of federally funded medical research through PubMed is an example of how ACRL's activism benefits college and research libraries.

The principal speaker for the 2008 ACRL President's Program at ALA Annual will be Dan Ariely, author of *Predictably Irrational: The Hidden Forces that Shape Our Decisions*, recently published by Harper Collins. His website is http://web.mit.edu/ariely/www/MIT/. Three panelists, librarians with less than five years experience in the field, will also participate in the program. ACRL/DVC member Brett Bonfield will be one of the participants.

Erika Lenke, ACRL Vice-President/President-Elect, told attendees that in the upcoming 2008 ACRL elections, members will be asked to vote on a ballot issue authorizing the creation of interest groups. Interest groups (IGs) are a way for ACRL to be more flexible and to respond more quickly to member interests. It is hoped that interest groups will help members who currently do not see a place for themselves in ACRL to combine with others with similar interests. ACRL will provide \$150.00 per IG (and groups will be eligible to apply for other funding). ACRL administration will check applications to ensure that IGs do not duplicate existing groups.

Candidates for ACRL vice-president/president-elect Lori Goetsch, Dean of Libraries at Kansas State University, and Janice Simmons-Welburn, Dean of University Libraries at Marquette University, were on hand to describe the issues they would focus on if elected. Also giving brief statements were the candidates for director-at-large: Linda Kopecky, Head, Research & Instructional Support Department, University of Wisconsin-Milwaukee; Daniel R. Lee, Interim Team Leader for Undergraduate Services, University of Arizona; and John A. Lehner, Assistant Dean for Library Systems and Planning, University of Houston. Mark Emmons, Coordinator, Information Literacy & Instruction Services, University of New Mexico, also a candidate, was unable to attend Midwinter due to a family emergency.

Michael McLane, director of the Catholic University Libraries, is temporarily taking over the Legislative Program responsibilities of Kara Malenfant, ACRL Scholarly Communications and Government Relations Specialist. He described the volunteer program for legislative advocacy. ACRL's goal is to have one legislative advocate per congressional district. The position involves writing to/visiting federal representatives. Legislative advocates also work to involve their campus administrators in legislation affecting libraries. There are still positions available; if you are interested in volunteering to be a legislative advocate for your congressional district, please send an e-mail to mcclane@oswego.edu.

Chapters Council Vice-Chair/Chair-Elect Kevin Merriman announced that nominations are being sought for Chapters Council vice-chair and secretary for 2008-2009. ACRL/DVC members who are also ACRL national members are asked to consider running for either position. Send a statement of interest to Kevin Merriman at kmerrima@uno.edu.

Mary Ellen Davis, ACRL Executive Director, announced that proposals for contributed papers, panels, workshops, and preconferences for the ACRL 2009 conference in Seattle are due by May 18, 2008. The application form can be at found at http://acrl.org/ala/acrl/acrlevents/seattle/program/program09.cfm.

For the first time, ALA is introducing a conference track at ALA Annual for refereed papers. This year there will be 20 slots for the presentation of papers by individuals. The deadline for submission is March 31, 2008. For more information, see http://www.ala.org/ala/eventsandconferencesb/annual/2008a/proposals.htm.

During the discussion period, ACRL toolkits were mentioned as valuable resources that address several of the issues facing academic libraries. ## ACRL Presidential Candidates Forum

The ACRL Candidates Forum, organized by the Chapters Council, was held at ALA Midwinter in Philadelphia on Sunday, January 13, at a luncheon sponsored by EBSCO. Candidates running for vice-president/president-elect and director-at-large were introduced. The president-elect candidates, Lori A. Goetsch, Dean of Libraries, Kansas State University, and Janice Simmons-Welburn, Dean of Libraries, Marquette University, answered a set of prepared questions (see below), as well as questions from the audience. Voting begins March 17, 2008 and ends April 24, 2008.

- 1. What experiences as an academic/research librarian prepare you for the responsibilities of this position? What strengths from those experiences will you bring to your presidency?
- 2. Of the various goal areas identified in the ACRL Strategic Plan 2020 document, which is most important to you, and how do you propose to achieve its objectives? How would you measure your success?
- 3. Librarians often receive comments of concern about the disappearance from libraries of print materials which are being replaced by digital collections. If you were called by National Public Radio with a question that related to ACRL's view of this change, how would you respond?
- 4. ACRL has promoted the ALA Spectrum Scholarship Program by making contributions to the ALA Scholarship Fund and by developing the ACRL Dr. E. J. Josey Spectrum Scholar Mentor Program. During your term as ACRL President, what additional steps might ACRL take to promote diversity among college and research librarians? Individuals may think differently about what diversity means. What does it mean to you?
- 5. How can ACRL help libraries increase their visibility on campus?
- 6. How can ACRL meet or understand the needs of small- to medium-size libraries?
- 7. What do you think will be the key issues facing academic and research libraries in the next two years? Are these covered in the ACRL Strategic Plan?
